In the course of the Parthenon Marbles debate, we've spent a lot of time refuting the claim that the sculptures' being in London gives more people the opportunity to see them. We've got the ripostes in our back pocket: Only a third of British Museum visitors go to Room 18; Athens is hardly a tourist backwater; if they were to have the greatest exposure, they'd be in Shanghai etc, etc. But I've just been to the Cast Courts at the Victoria and Albert Museum and had a moment of clarity about the exposure argument. There's a subtext when it counters our insistence that the marbles shouldn't be in the BM. It's a good thing that so many people can see them in London, despite the iffy nature of their acquisition.

DEBATE: Should The Elgin Marbles Be Repatriated? | Sumption, Torretta, Selwood; Spivey, Titi, Herman

Listen to this insightful debate as to whether the Elgin/Parthenon Marbles should be repatriated. The marbles are ancient Greek sculptures from the Parthenon, now housed in the British Museum. The controversy stems from Greece's claim that they were illegally removed by Lord Elgin in the 19th century, while the UK maintains their legal acquisition and the museum's role in preserving them.

In favour of the motion:

Nigel Spivey: a British classicist and academic, known for his expertise in classical art and archaeology, who serves as a Senior Lecturer in Classics at the University of Cambridge and has appeared as a presenter on various television programs, including the BBC series 'Cunk on Earth'.

Catharine Titi: an international lawyer and research associate professor at the French National Centre for Scientific Research (CNRS), specializing in public international law, international investment law, and cultural heritage law, notably known for her work on the Parthenon Marbles and international arbitration.

Alexander Herman: the Director of the Institute of Art and Law in the UK, recognized for his expertise in art law, cultural property, and restitution issues. He has written extensively on topics like the Parthenon Marbles dispute and has contributed to discussions on cultural heritage and legal frameworks surrounding art.

In opposition of the motion:

Lord Sumption: a British author, historian, and retired Supreme Court Justice, known for his legal career, his historical works like the multi-volume "Hundred Years War," and his public commentary.

Mario Torretta: a classical archaeologist trained in Sicily and in Athens. His expertise covers classical Greek architecture and sculpture, Ancient Athens and the Elgin Marbles.

Dominic Selwood: an author, historian, journalist, and barrister, known for his works on history including the novel "The Sword of Moses" and nonfiction like "Anatomy of a Nation: A History of British Identity in 50 Documents." He regularly contributes to newspapers like the Daily Telegraph on historical topics and has a background in medieval history.

Return or Retain? The Parthenon Marbles Debate, with Noel Malcolm and Ed Vaizey

For almost 40 years, the Parthenon Marbles, or Elgin Marbles as they are also known, have been at the centre of the great restitution debate. Taken from Greece in contested circumstances by Lord Elgin in the 19th century, the marble sculptures that were part of the Parthenon and other structures on the Acropolis are housed in the British Museum. UK law prevents the museum from giving away objects in its collection, but the organisation's chair, former chancellor George Osborne, is said to be in talks to loan the statues to Greece long term in exchange for other ancient artworks.
